



Home Education Instructional Program Tuition Agreement

REMD Inc, dba as Integral Academy of Palm Coast, and the undersigned parent/guardian, by entering into this tuition agreement to enroll their child _____ into _____ - _____ homeschool program for the 20__ - __ school year, executed by the parents on the signed date below, agree as follows:

Full-Time Homeschool Program (4 days/week)

- Quarter 2** – November 15th, 2026 (Reserve \$1700)
- Quarter 3** – February 15th, 2027 (Reserve \$1700)
- Quarter 4** – April 15th, 2027 (Reserve \$2,550)

Part-Time Homeschool Program (2 days/week)

Scholarship Recipients (UA and PEP) parent/guardian must reserve funds via EMA account by the following dates:

- August Payment** (Due August 1st) - \$500 (Pro-Rated)
- Quarter 1** – September 15th, 2026 (Reserve \$1800)
- Quarter 2** – November 15th, 2026 (Reserve \$1800)
- Quarter 3** – February 15th, 2027 (Reserve \$1800)
- Quarter 4** – April 15th, 2027 (None)

Important: Parents/Guardians shall pay Integral Scholars Homeschool Program fees based on the rates specified above. **Tuition fees will not be adjusted for late arrival, early pickup, or missed days.**

1. **Consent:** This agreement is entered into with mutual consent of Parent and Integral Academy.
2. **Enrollment Deposit:** Integral Academy requires a \$300 non-refundable registration fee to reserve a spot for student in the 2025-2026 school year.

3. **Payment obligation:** Parents/Guardians have an individual and joint obligation to pay all tuition and fees under this agreement. Parents failure to pay any amount when due pursuant to the terms of this Agreement, may, at Integral Academy sole discretion, result in the suspension or dismissal of the student from the program. Parents shall pay any costs and attorney's fees Integral Academy incurs in collection of Parent's outstanding balance. Parents understand and agrees that \$50 fee will accrue 5 business days after payment is due. Early Withdrawal:
4. **Late Payment Fees:** Parents understand and agrees that **\$50** fee will accrue 5 business days after payment is due.
5. **Early Withdrawal:** Parents must provide at least Thirty (30) days signed WRITTEN NOTICE to the Head of Integral Academy to withdraw the student from the program during the Homeschool year. Tuition will be collected during the 30-day notice period, and after the 30-day notice period, parents will no longer be responsible for tuition payments pursuant to this Agreement. However, as an exception to our standard withdrawal process, while we still require a 30-day notice, ***withdrawals cannot take place during Quarter 4 (the final two months of the year)***. Families are still responsible for Quarter 4 payment in full. This ensures that our staffing and program operations remain stable, preventing last-minute disruptions.
6. **Late Pick-Up Fees:** Parents/Guardians agree to pay \$1.00 for each minute after designated pick up time. Please see schedule with drop-off and pick-up times. This overtime fee shall be paid at the pick-up time.
7. **Removal from the Program:** Integral Academy retains the right to terminate this contract without notice for the following reasons:
 - a) The child(ren)'s behavior is destructive, uncontrollable, violent, or threatening to the other children or teachers at Integral Academy facility. This determination is made at the sole discretion of the provider.
 - b) A parent's/guardian's behavior is threatening or abusive to the other children or providers at Integral Academy facility.
 - c) Program fees are two weeks or more delinquent. Payment Agreement
8. **Payment Agreement:** Parent/Guardian understands and agrees that the majority of Integral Academy expenses and obligations are incurred on an annual basis, that financial commitments for Integral Academy services are made based upon anticipated enrollment, and that the educational operating expenses do not diminish with the departure of some students over the course of the school year. Parents understand and agree that, regardless of Student's absence, withdrawal or dismissal from the program, Parents remain obligated to pay the amount of tuition set forth in sections 3 and 5 of the Agreement, consistent with the 30-day notice period, as liquidated damages and assume full responsibility for payment.
